    - iii. Woodinville, WA 98077
- 4. Returns from out of the US
  - a. Value the warranty return items at \$1.00 each
  - a. Ensure that the total shipment is valued at less than \$200, and any additional charges are **pre-paid**, including, but not limited to:
    - a. US Customs Duties
    - b. Govt. Charges other than duties
    - c. Brokerage charges
    - d. Consignee Charges (Freight)
- 5. The returned product will be evaluated for warranty consideration
- 6. In cases of a manufacturing defect, we will repair or replace the unit, and return it at our expense.
- 7. If the *unit is out-of-warranty and it can be repaired*, we will provide a repair quote.
